# 2024 Recount and Audit Certification Report

# Recount 20A-4-401

Review postmarks on all "too late ballots." Ballots that count must have a valid postmark We received (November 4 or earlier AND have been received before noon on the date of your county NCH Ewel canvass) (20A-3a-204(2)). These ballots remain unopened during the review.

- Review uncounted ballot envelopes under <u>20A 3a part 4</u>. These ballots remain unopened during the review:
  - Beview all uncounted mail ballots that were challenged (20A-3a-401(3)). No Ewerg
  - Review all cured affidavits to ensure each corresponding ballot has been counted (20A-3a-401(5)). Comment
  - Ballots that were not cured before 5:00 pm three days before the original canvass began cannot be counted (<u>20A-3a-401(5)</u>).
    - Review all uncounted provisional ballots (<u>20A-3a-402(1)</u>).

More Make detailed notes on any additional ballots that are being included in the recount that were not in the original count.

A Rescan all ballots (20A-4-401(b)(iii))

Verify and reconcile that all ballots have been counted, including UOCAVA and remakes.
 Perform adjudication.

Commit results.

Submit batch numbers to the Lt. Governor and conduct a 3% post-recount audit (State of Utah Election Audit Policy - Recount Audits). The audit will only be conducted on the eligible race. The 3% will be of all ballots scanned in the recount. In some jurisdictions, the batches may contain ballots outside of the eligible race. Those ballots can be skipped for this audit. Communicate with the Lt. Governor's Office as you progress through your count so we can be ready to turn the numbers around quickly.

# Post-Recount

Complete final "OFFICIAL RESULTS" for the RECOUNT that only contains results for eligible race

Reconvene the Board of Canvassers immediately (<u>20A-4-401(11)</u>). Check with your commission/council and attorney on the noticing requirements (<u>52-4-202</u>).

Boards of Canvassers shall canvass the recounted results and transmit a report to the Lt. Governor that details the number of votes for each candidate (20A-4-401(11)).

Sign a new audit summary report and send it and the signed canvass report to the Lt. Governor.

□ Upload recount results for the eligible race to the state election results website. This will be the recount website, not the November 5 General website. Only post results after your canvass is complete.

Verify that the state results site matches the official county results.

Publish the certified report of the board of canvassers as a Class A notice (20A-4-304(6)).
